However, payment of membership dues is deductible under Section 162 of the Internal Revenue Code as ordinary and necessary business expense subject to restrictions imposed as a result of association lobbying activities. NAPIM estimates that the nondeductible portion of your dues (the portion that is allocable to lobbying) is 2%.

EXCERPTS FROM NAPIM BY-LAWS

ARTICLE I – NAME AND OBJECTS

Section 2 The purposes of the Institute shall be:

- (a) To give broad technical support to NAPIM in its relationships with suppliers, customers, consumers, and governmental and environmental agencies and to engage only in such related projects and activities, which shall have broad value to the printing ink industry.
- (b) To evaluate test methods and test instruments and report to industry regarding its findings.
- (4) To do anything necessary and proper for the accomplishment of any object herein set forth or which shall be recognized as proper and lawful objectives of trade associations, all of which shall be consistent and the public interest, as well as in the interest of this industry and trade.

ARTICLE III – TECHNICAL ASSOCIATE MEMBERSHIP (NON-VOTING)

Section 1 Any company or company division supplying products or technical expertise to the members of NAPIM or their customers and having a recognized capability in technical matters shall be eligible for Technical Associate Membership in this Institute, provided that no company or company division shall be so eligible if it or any of its affiliates (either divisions of the same company, subsidiaries or parent

company) is eligible for active membership in NAPIM and is not a member of NAPIM.

Section 2 Any person, firm or corporation eligible for Technical Associate Membership in the Institute may be elected into membership:

- (a) Upon making written application therefore,
- (b) Upon election by a majority of the votes of the Executive Committee, and
- (c) Upon payment of dues then current.

Section 3 Technical Associate Members shall be divided in such classes, and shall pay dues as may be fixed by the Executive Committee

ARTICLE IV – RESIGNATIONS

Section 6 Any member may, by giving written notice of such intentions, withdraw from membership. Such notice shall be presented to the Board of Directors at its next succeeding meeting. Withdrawal shall be effective upon fulfillment of all the obligations ninety days from the date on which the Board of Directors receives the notice of withdrawal.
