

Trump Tariffs - Fentanyl

- Fentanyl tariffs remain in place for USMCA imports that do not meet USMCA rules of origin.
 - For chemicals, including pigments the chemical reaction rule is in place.
 - A change in classification 3204.11 through 3204.90 from any other subheading, (6-digits) including a subheading within this group.
 - Means dye-based pigments are originating.
 - A change to headings 3207 through 3215 from any other chapter.
 - Except from heading 3206 and 3212, except for TiO2.
 - Means that Inks, Paints and Coatings need to have a territorial organic pigment or territorial TiO2 to be considered USMCA compliant.
- If the USMCA Rules of Origin are not met, the tariff has been set at 25% for Mexico and Canada.
 - It is expected that importer would need to include tariffs that are associated with the "actual country of origin".
- China & Hong Kong: 20% across the board no exceptions.

- Canadian retaliation: None of the HTS numbers of interest in this presentation are of concern.
- Mexico has not yet retaliated.

"Current State of Reciprocal Tariffs"

- In-transit products are exempt from the reciprocal tariffs if (1) loaded onto a vessel at the port of loading and in transit on the final mode of transport prior to entry into the United States before 12:01 a.m. EDT on April 5, 2025, AND (2) are entered for consumption, or withdrawn from warehouse for consumption, on or after 12:01 a.m. EDT on April 5, 2025, and before 12:01 a.m. EDT on May 27, 2025.
- Rates:
 - USMCA is exempted for products that meet USMCA Rules of Origin
 - If USMCA ROO are not met, It is expected that importer would need to include tariffs that are associated with the "actual country of origin".
 - China & Hong Kong: 125%, with exceptions
 - All other countries: 10%, with exceptions
- Trump Administration is said to be negotiating with dozens of countries to mitigate these tariffs.
- China has imposed substantial tariffs on U.S. Imports, including energy.

Tariffs on Ships

- Trump Administration has now imposed fees on Chinese Vessels operating into U.S. Ports. Goal is to boost U.S. Ship Building.
- Chinese operated Chinese vessels:
 - Fees start in 180 days at \$50/NT and then increase by \$30/NT.
- Operators of Chinese vessels:
 - Fees start in 180 days at \$18/NT and then increase by \$5/NT.
- A second phase will start in 3 years. Program is meant to last for at least 3 decades!
- This is a highly complex situation this slide is not meant to present the entire picture – but to make you aware of these new fees to be imposed before the end of this year.

WARNING on Tariffs

- The Trump Administration is determined to prosecute "avoiders".
- Most US Free Trade Agreements that impact the Chemical sector, except Israel, have the chemical reaction rule. The rules for Inks in many of the FTAs include restrictions on Inorganic Pigment tariff shifts. They vary on Paints and Coatings by agreement.
 - Israel has GSP style rules of origin double substantial transformation and 35% value content.
 - Whenever an FTA is in place, it sets the standards for substantial transformation.
- If there is no FTA, then substantial transformation is the "standard".
 - It is unlikely that the production of an Ink, paint or coating will meet the requirements for "substantial transformation.
 - When in doubt seek a binding customs ruling.
- Note to U.S. Importers: The overseas shipper of a product is outside of the jurisdiction of the USA – the person to be prosecuted is the U.S. importer of record!
